



Thank you for purchasing the Connect In-Ear Wired Stereo Earphones. For best results, read this manual before use.

Directions

To play or pause the current audio press on the Multifunction button.

To go to the next track press the Multifunction button twice.

To go back a track press the Multifunction button three times.

Press and hold the volume up or down buttons for approximately 2 to 3 seconds to increase or decrease volume.

Additional Features

Depending on what device the earphone is connected to additional features may be available.

Voice Assistant


If the earphone is connected to a smartphone with a voice assistant enabled (Such as Siri for iOS, or a Google Assistant for Android), you can turn on voice assistant from your earbuds by pressing and holding the multifunction button for 2 seconds.

Phone Control

If the earphone is connected to a smartphone, you can accept or hang up calls by pressing the multifunction button. To decline calls press and hold the multifunction button for 2 seconds.

In-line Microphone

The earphones contain an In-line microphone that you can use to talk during calls.

Safety Precautions

When using your Earphones, basic safety precautions should always be followed, including the following:

1. **READ ALL INSTRUCTIONS BEFORE USING YOUR EARPHONES.**

5. Always press all buttons carefully. Do not manhandle your earphones.
6. Do not use your earphones at temperatures under 32°F (0°C) or over 104°F (40°C).
7. Do not drop your earphones, throw it, or subject it to strong impacts or physical trauma.
8. If you detect any abnormalities when using your earphones, contact the manufacturer for support. In addition, do not continue to use your earphones if you detect any smoke or fire.
9. This product is not intended for commercial use.
10. Unplug your earphones when not in use for extended periods of time.
11. Please recycle or dispose of your earphones properly based on the laws and rules of your municipality. Contact local recycling facilities and/or the manufacturer for further information.
12. Clean your earphones using a soft cloth or paper towel. Do not use harsh chemicals when cleaning your earphones, and never submerge your earphones in water.

Warranty
